	Loan facilities include <ul style="list-style-type: none"> \$1,950K which is secured against the Ballarat property. The loan is with Moneytech and is repayable in 24 monthly instalments. Interest is payable at 14% per annum. This is fully drawn down. During the prior quarter the company borrowed a total \$420,000 from BizCap. The amount is repayable in 32 weekly instalments with interest and fees of \$142,800 payable over the course of the loans. Of this amount \$118,000 remains payable at 31 December 2021.

Answer: On 11 June 2021, the company announced that it had entered into an agreement to sell its Ballarat property for \$7.5million. The sale is conditional upon approval from Development Victoria. The board remain confident that this transaction will be approved.

During the quarter the company announced it has secured \$3.6m (before costs) via a secured convertible note financing from a group of sophisticated and professional investors.

8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: The Company expects to continue its operations and meet its business objectives due to funds raised and has inventory at a cost value of approximately \$667,726.
