Request for trading halt: Air New Zealand Limited (ASX Code: AIZ, NZX Code: AIR)

<u>We would like the trading halt to commence from 4:00pm (NZT) on 30 March 2022.</u> For completeness we are not seeking a trading halt in respect of our quoted bonds on NZX (AIR020).

Reasons for trading halt: Pending release of a material announcement in relation to the company's recapitalisation plans.

How long we want the trading halt to last:

NZX: Until NZX market open on 31 March 2022. ASX: Pending an announcement to be made by the company relating to the lifting of the NZX trading halt on its ordinary shares prior to ASX market open on Thursday, 31 March 2022.

The event we expect to happen that will end the trading halt: NZX: NZX market open on 31 March 2022. ASX: market announcement made by the company prior to ASX market open on Thursday, 31 March 2022.

Other information necessary to inform the market about the trading halt or that ASX or NZ RegCo have requested: N/A.

Information to include in any market memorandum relating to the halt: Air New Zealand has today requested a trading halt of its ordinary shares on the NZX Main Board and the ASX pending release of a material announcement in relation to its recapitalisation plans. Air New Zealand expects the trading halt to continue until market open on 31 March 2022.
