



### MARCH QUARTER 2022 UPDATE<sup>1</sup>

Transurban today released its March quarter 2022 update. During the period, Average Daily Traffic (ADT) increased by 0.4% compared to the March quarter 2021 and was 3.4% lower compared to the same period in 2019.<sup>2,3</sup> See Appendix 1 and 2 for full traffic information for the March quarter.

The March quarter again demonstrated traffic recovery occurring in line with the progressive easing of government restrictions and increased economic activity.


Monthly ADT data 2022 vs 2019 (%)



Severe rainfall events occurred in late February to early March in Queensland and NSW, with traffic in those markets recovering quickly as weather patterns normalised. Traffic recovery is also continuing in Victoria with CityLink recording its highest monthly ADT since the start of the COVID-19 pandemic in March 2022.

Travel on Australian airport exposed assets improved over the quarter, in line with increasing domestic travel, with February and March traffic on these roads the highest it has been since March 2020.

In the Greater Washington Area, March traffic along the 95 Express Lanes was the highest since the start of the pandemic, supported by discretionary or holiday travel. In Montreal, traffic progressively improved throughout the period, with overall traffic up slightly for the quarter vs pre-pandemic levels, despite restrictions in place in January.

### West Gate Tunnel Project update

In Melbourne, Transurban has entered into detailed documentation with the Victorian Government and the CPB John Holland Joint Venture on revised terms for delivery of the West Gate Tunnel Project. The increased contract sum and the new project completion date of late 2025 are consistent with the announcement on 17 December 2021<sup>4</sup>.

Progress has continued on all three sections of the Project. The first Tunnel Boring Machine (TBM) has excavated around 430 metres of the outbound tunnel, with the second TBM finalising commissioning. More than 70% of widening works on the West Gate Freeway are now complete and more than 650 metres of the new elevated roadway above Footscray Road has been built.

### Key regional updates

### Sydney

- For the quarter, ADT decreased by 5.0% to 890,000 trips, with Sydney experiencing the
  wettest start to a year on record, as well as government restrictions associated with the
  COVID-19 Omicron variant
- Compared to 2019, ADT was up 9.8%
- Average workday traffic decreased by 5.9% and average weekend/public holiday traffic fell by 2.1% for the quarter
- Car traffic decreased by 5.1% and large vehicle traffic decreased by 3.8% for the quarter
- M4-M5 Link Tunnels on track for completion in FY23. The road paving has been fully completed, and mechanical and electrical fit out more than 70% complete

#### Melbourne

- For the quarter, ADT increased by 5.6% to 713,000 transactions, with restrictions related to the Omicron variant gradually lifting throughout the period
- ADT was down 16.5% vs 2019
- Average workday traffic increased by 3.4% and average weekend/public holiday traffic increased by 11.7%
- Car traffic increased by 6.6% and large vehicle traffic increased by 2.5%

#### Brisbane<sup>5</sup>

- For the quarter, ADT decreased by 0.6% to 401,000 trips. Brisbane experienced significant rainfall events during the quarter, including periods of flooding
- ADT was up 0.5% vs 2019
- Average workday traffic decreased by 1.0% and average weekend/public holiday traffic decreased by 0.1%
- Car traffic decreased by 1.9% and large vehicle traffic increased by 3.5%
- Transition of all Brisbane operations to a new centralised traffic control room is progressing
  well, with two of four sites now migrated. The final control room is expected to be integrated by
  the end of 2022 (calendar)

#### **North America**

- For the quarter, North America ADT increased by 19.6% to 121,000 trips, with ADT down 10.7% vs 2019<sup>6</sup>
- Average dynamic toll price for the quarter increased by 15.5% to USD8.02 on the 95 Express Lanes, and increased by 32.6% to USD4.62 on the 495 Express Lanes
- Rolling 12-month peak direction traffic of 2,924 vehicles per hour on the A25
- Transurban is working with the D&C subcontractor on construction challenges on the Fredericksburg Extension Project. Project is currently tracking behind the 2022 scheduled opening date, with schedule under review. Arbitration hearing scheduled for August 2022
- 495 Northern Extension Project reached financial close on 2 March 2022. Project construction commenced in March with the opening anticipated for 2025


