Reappointment of Michael Cooper as Managing Director

PFT is pleased to announce that the Managing Director, Michael Cooper, has agreed to extend his role as the Managing Director of PFT until at least 30 April 2024. A summary of the key terms of Mr Cooper's re-appointment are set out below:

1. Mr Cooper has recently acquired shares on market and currently holds 3,093,893 fully paid ordinary shares (~5% of PFT's shares on issue) and 1,300,000 options that expire on 30 April 2023.

The Chairman of PFT, Malcolm McAully, commented that Michael has been the key driver to the very strong growth PFT has enjoyed since its listing on the ASX and his continued commitment is welcome.

Appointment of Charles Hughes as Chief Financial Officer

PFT has appointed Charles Hughes as its Chief Financial Officer. Charles has previously worked in the aquaculture industry in Tasmania and for 14 years in commercial, financial, and planning roles with Huon Aquaculture. He has also worked in corporate roles at Coca-Cola Amatil, Wesfarmers, and James Hardie, where he assisted with corporate planning and business acquisitions.

Charles has a Bachelor of Rural Science and Graduate Diploma in Financial Management from the University of New England and is a member of CPA Australia and Fellow of FINSIA (Graduate Diploma in Applied Finance and Investments).

On commenting on the appointment, Michael Cooper said "Charles has a wealth of experience which is unmatched and fundamental for a nimble, albeit diverse, business like PFT and with its significant expansion plans".
