

# **QUARTERLY ACTIVITIES REPORT - MARCH 2022**

#### **HIGHLIGHTS**

#### NEW ZEALAND GOLD PROJECTS - MANORBURN, CENTRAL OTAGO

- Prospecting Permit PP60716 over the Company's 100% owned Manorburn Project granted, significantly expanding NAE's strategic landholding within the highly endowed Central Otago Gold Belt, Central Otago New Zealand
- Manorburn secures an area of 235.78km<sup>2</sup> situated immediately adjacent to Santana Minerals (ASX:SMI) Bendigo-Ophir Gold Project, some 85km west of Oceana Gold's (ASX:OGC) World Class Macraes Gold Mine.
- Manorburn strengthens NAE's Central Otago Gold Project (COGP) which includes the OPQ and Lammerlaw Projects where exploration for Macraes-style orogenic gold mineralisation is already well advanced.
- Exploration and evaluation of the Manorburn Project commenced as a high priority
- Numerous key target areas identified following a review of legacy exploration data
- Field activities including mapping and surface geochemical surveys are planned to commence Q2

#### **PILBARA GOLD PROJECTS**

- Results from the RC drilling campaign completed late 2021 expected in coming weeks.
- Assay turnaround has been longer than anticipated due to an unprecedented backlog of samples at the laboratory.
- Phase 2 Drilling on high priority Hemi-style and structural gold targets planned to recommence
   Q2-Q3
- Geochemical soil surveys across all projects planned to recommence Q2
- Ongoing target generation, refinement and prioritisation underpinned by results obtained from the current phase of exploration activity

## **CORPORATE**

**New Age Exploration (ASX:NAE) (NAE** or the **Company**) is pleased to provide shareholders with the Company's Quarterly Activities Report for the period ending 31 March 2022.

The key activity for this quarter involved the significant expansion of NAE's strategic landholding within the highly endowed Central Otago Gold Belt, Central Otago New Zealand, following the successful granting of Prospecting Permit PP60716 over the Company's 100% owned Manorburn Project. The granting of the Manorburn permit strengthens the Company's position in New Zealand and Otago where it already has a well-advanced gold exploration program with the Lammerlaw and OPQ Exploration Permits. Manorburn adjoins Santana Minerals (ASX:SMI) recent Gold discovery in Bendigo-Ophir providing an exceptional opportunity to advance exploration efforts within this highly prospective Gold district in New Zealand.

For its Pilbara projects, the Company is progressing with activities that were commenced in the previous quarter, including preparation to recommence drilling on high priority Hemi-style and structural gold targets and surface geochemical soil surveys.

NAE considers its Pilbara area to have the potential to host Orogenic gold deposits, Hemi-style IRGS and Shear Zone hosted lode gold deposits, epithermal gold mineralisation, Whim Creek style sedimentary hosted VHMS Copper-Zinc-Lead-Silver base metal deposits and rare metal LCT pegmatite deposits. Its project tenure surrounds De Grey Mining's' Mallina Gold Project and the recently discovered Hemi Gold Deposit (Refer ASX: DEG) and is in close proximity to the world class rare metal LCT pegmatite mining operations of Wodgina (Mineral Resources ASX:MIN) and Pilgangoora (Pilbara Minerals ASX: PLS)

# **NEW ZEALAND GOLD PROJECTS - MANORBURN GOLD PROJECT**

In February, NAE announced that Prospecting Permit PP60716 was granted. (ASX Announcement 23 February 2022) The Permit secures the Company's 100% owned Manorburn Project which together with the Company's existing OPQ and Lammerlaw Projects expands NAE's landholding within the highly prospective Central Otago region to a total 558km<sup>2</sup>. NAE's Central Otago Gold Project (COGP - Manorburn, OPQ, Lammerlaw) is centred 50-100 kilometres west-northwest of Dunedin within the highly prospective Central Otago Schist/Gold Belt, South Island New Zealand. The project tenements are strategically located in close proximity to the recent discoveries by Santana Minerals at the Bendigo-Ophir Gold Project and the World Class Macraes Gold Mine, owned and operated by Oceana Gold. (Refer to ASX Reports ASX: SMI and ASX: OGC).

The Central Otago Schist/Gold "Belt" is regarded as one of the most highly endowed yet underexplored regions in New Zealand. The World Class Macraes Gold Deposit is the largest active gold mine in New Zealand with a Combined Production and Current Mineral Resource totalling in excess of 10 Million ounces of gold (Refer ASX:OGC). Exploration activity in the region has increased significantly in recent times with the discovery of the Bendigo-Ophir Deposits by Santana Minerals (Current Mineral Resource Estimate 643K ounces of gold. Refer ASX:SMI)




Figure 2: Location of NAE's Central Otago Gold Project

NAE considers its COGP to have the potential to host structurally controlled orogenic gold mineralisation similar to that at Macraes and to that of the more recent discoveries of Santana within extensions and/or repetitions of the structural corridors of the Hyde-Macreas and Bendigo – Ophir Shear Zones. Numerous historical gold occurrences have been reported from within each of the project tenement areas confirming the potential of each to host significant mineralisation. Refer Figure 2.

## **Next Steps**

Evaluation of the Manorburn Project is a high priority for the Company and a multi-disciplinary geoscientific exploration effort is now in progress.

# The program includes:

- A comprehensive desktop review of legacy geoscientific exploration data COMPLETED
- Detailed assessment of all available geophysical data IN PROGRESS
- Detailed geological field mapping TO COMMENCE Q2 2022 (delayed due to farming activities impacting access)
- Regional scale and detailed surface geochemistry surveys TO COMMENCE Q2 2022 (delayed due to farming activities impacting access)
- Drill testing of key target areas will follow upon completion of the mapping and surface geochemical surveys.



# PILBARA GOLD PROJECTS - WESTERN AUSTRALIA

#### **Project Background**

NAE's Central Pilbara Project comprises 17 Exploration Licences (all granted) which collectively secure a total area of 2,030 km2 centred over the highly prospective yet under-explored Mallina-Whim Creek Basin, Central Pilbara Tectonic Zone (CPTZ), Pilbara Craton Western Australia.

The Project surrounds De Grey Mining's' Mallina Gold Project and the recently discovered Hemi Gold Deposit (Refer ASX: DEG), and is near the world class rare metal LCT pegmatite mining operations of Wodgina (Mineral Resources ASX:MIN) and Pilgangoora (Pilbara Minerals ASX: PLS)

The region has remained under-explored due largely to its relative remoteness, extensive areas of recent cover and restricted access.




Figure 3: Central Pilbara Project

NAE considers the area to have the potential to host Orogenic gold deposits, Hemi-style IRGS and Shear Zone hosted lode gold deposits, epithermal gold mineralisation, Whim Creek style sedimentary hosted VHMS Copper-Zinc-Lead-Silver base metal deposits and rare metal LCT pegmatite deposits. (Refer Figure 3.)

# **Ongoing Activities**

Target generation, refinement and prioritisation underpinned by results obtained from the current phase of exploration activity is ongoing.

In late October, the Company announced that it had completed a synthesis of all available geophysical datasets over its Central Pilbara Project. Refer Figure 3. The recent work identified 104 new Hemi-style IRGS targets, 66 new structural targets and refined previously reported targets. Numerous high priority targets display clear similarities with the Hemi Gold Deposit and with those associated with the Scholl, Mallina and Tabba Tabba Shear Zones. None of the new targets had been previously drill tested.

Importantly, refinement of previously identified targets now indicated that much of the initial campaign of drilling by NAE did not reach target depths due to limited capacity of the rig which was available at the time and therefore those targets also remain untested. Low order gold and base metal geochemical anomalism reported from this phase of drilling is however encouraging in that it may be associated with a deeper, untested source.

In addition, recent helicopter supported field reconnaissance confirmed the presence of lithium-tantalum-tin rare metal pegmatites at several locations within the interpreted extension of the world class Wodgina-Mt. Francisco Rare Metal Lithium-Caesium-Tantalum (LCT) Pegmatite Belt ~50km southwest of Mineral Resources' (ASX: MIN) Wodgina Mine (one of the largest hard rock lithium mines in the world) and ~29km southwest of Pilbara Minerals' (ASX: PLS) Mt. Francisco Lithium-Tantalum Project. (Refer Figures 3 and 6.)

# **Prospect Scale**




Figure 4: NAE targets over Bullock Well and Quartz Hill Gold Projects.




Figure 5: NAE targets over Brahman and Droughtmaster Gold Projects.

The geophysical data synthesis significantly improved the Company's understanding of the regional framework and structural architecture of the project area. The work identified 104 new Hemi-style IRGS targets, 66 structural targets and refined previously reported targets. (Refer Figures 4 and 5.)

#### **Rare Metal Pegmatites**




Figure 6. Rare Metal Pegmatite Zonation – Schematic Model after Cerny et al 1993

NAE's recent helicopter supported field work confirmed the presence of historically mapped occurrences of rare metal pegmatites with recorded Lithium-Tantalum-Tin-Beryl mineralisation at several locations along strike to the southwest of the Wodgina-Mt. Francisco Lithium-Caesium-Tantalum (LCT) Pegmatite Belt. Historical reports indicate small scale production of tin, tantalum and beryl. None of the occurrences have been previously drill tested. Assessment of all project areas for additional rare metal pegmatites is ongoing. Figure 6 presents a schematic model of mineral zonation within rare metal pegmatites.

The Company is planning to recommence its Phase 2 drilling programme which was suspended during the Summer cyclone season next quarter. The program, which commenced in November 2021 was designed to follow-up high priority targets defined from its Phase 1 drilling in conjunction with a pipeline of new targets identified from recent data synthesis and proprietary data filtering technology undertaken on multiple geophysical data sets by Fathom Geophysics. In late December, the Company announced that the first 1500m of the proposed 5000m Phase 2 drilling programme had been completed.

The Company engaged Strike Drilling to undertake the program and was committed to completing as much of the planned drilling as possible prior to the closure of the 2021 field season. Helicopter and ground supported regional and prospect scale soil geochemical surveys over priority areas at all Projects to further refine additional targets ahead of follow-up drill testing.




Figure 7: Location of NAE's Central Pilbara Brahman and Droughtmaster Gold Projects over regional grey scale aeromagnetics showing planned drilling and areas of soil geochemical surveys.

Initial focus was on the Brahman and Droughtmaster Gold Projects (E47/3958 and E47/5064/5065 respectively) which are located north of, and within ~50km of De Grey Mining's (ASX:DEG) Mallina Gold Project and the recent Hemi gold discovery. (Refer Figure 7.)

#### **Next Steps**

Assay results from the RC drilling completed prior to the end of the 2021 field season are expected in the coming weeks. Whilst the Company has been frustrated with unprecedented delays in assay turnaround it is important to note that this phase of evaluation has only just begun. Drilling is scheduled to recommence during the next quarter to continue testing the large number of high quality targets identified from the work completed to date and to follow up areas of interest generated from the 2021 campaign.



Ongoing target generation, refinement and prioritisation will be underpinned by results obtained from the current phase of exploration activity including surface geochemical surveys, drilling, continued assessment of airborne and ground geophysical data.

# **NEW ZEALAND GOLD PROJECTS - LAMMERLAW GOLD PROJECT**

In October last year, the Company advised that its technical team at Verum Group commenced work on its New Zealand project for the 2021/2022 summer season. During that month, further ridge and spur soil lines were completed along electromagnetic lineaments identified in April 2020. NAE also obtained an access arrangement within the Otago Pioneer Quartz (O.P.Q.) Project to complete trenching along the O.P.Q mineralised trend.

# **Lammerlaw Ridge and Spur Soil Lines**




Figure 8: EM lineaments overlain by 8200HZ resistivity results

NAE will continue ridge and spur soil sampling along the northwest trending geophysical lineaments within prospecting permit 60544. These lineaments occur at boundaries between high and low response on airborne electromagnetic surveys that represent potential contact zones between pelitic (high response) and psammitic (low response) schist, see Figure 8. These contact zones preferentially host mineralised shearing and veining in other deposits in the Otago Schist.

Eight ridge and spur soil sample lines at 50m spacings were completed in October 2021.

Of the eight lines, four are located on the northern EM lineaments previously sampled in the 2020/2021 field campaign where anomalous gold-arsenic trends were identified and NAE has applied for a exploration permit over ~75km². These four lines are located along strike to the northwest on Department of Conservation land which NAE holds a minimum impact activity consent to carry out the soil sampling.

The remaining four ridge and soil lines are located on the southern EM lineaments yet to be tested by NAE. The southern EM lineaments show a similar geophysical response to the northern EM lineaments where NAE has identified anomalous gold-arsenic zones from previous soil sampling.






Figure 9: Planned Ridge and Spur Soil Lines at Lammerlaw

Further in fill soil lines will target Arsenic, Gold or base metals anomalies which are associated with low angle shear-host orogenic gold mineralisation.

NAE is also actively working towards gaining access to the land over the western side of the Lammerlaw Gold Project to complete the additional eleven (11) ridge and spur soil lines as shown in Figure 9.

# O.P.Q. Trenching

NAE has obtained an access arrangement to farmland in MEP60502 to complete trenching as part of Phase 2 exploration programme at O.P.Q. Trenching is planned along strike extension of the O.P.Q. trend identified from previous shallow percussion drilling completed in 2019. Trenching was planned in areas where basement schist is <2m from surface. Trenching commenced from mid-November after lambing was completed by the landowner and completed prior to the end of 2021.






Figure 10: O.P.Q. estimated strike length. Taken from NAE ASX Announcement 12 December 2019

A follow up Phase 3 programme, comprising RC and/or diamond drilling (>50m deep holes), will be developed to test the depth of the southern strike extensions of O.P.Q.






Figure 11: Otago Tenement Map showing NAE's projects and other notable explorers in the region
