For the purposes of #7.3 above, the loan is valued at a rate of AUD1:USD0.7497. Interest rate is 1.00% per year calculated on a non-compounding, non-adjustable basis. Maturity date is 5 years from the date of issue. During the quarter, BID was notified that a second facility for USD242k, also issued under the US Government Paycheck Protection Program on May 21, 2020 had been forgiven. It is no longer included in the above figures.
