Year-to-date cash flows from relevant mining and exploration activities at Mt Carlton relates only to the period post completion of the transaction to acquire Mt Carlton (14 December 2021 – 31 March 2022). All other cash flows for the period 1 October -14 December 2021 were subject to a locked box arrangement in line with the terms of the Asset Sale Agreement. Following an audit of the cash flows during the locked box period, a final payment of \$11.2m was made to Evolution Mining and will be reflected within the net cash flows in the June 2022 quarter. This payment reflects a material build in working capital (mostly finished goods) during the locked box period, which has since largely been drawn down to normalised levels.
7. Inclusive of acquisition/integration costs, totalling approximately \$2.9M for the quarter (\$3.6M for year-to-date).
8. Amounts disclosed in section 6.1 and 6.2 relate to salaries and fees (including superannuation) paid to non-executive directors, the Managing Director and the Technical Director during the quarter.
