Syrah recommences Balama logistics movements

- Syrah has lifted a temporary suspension on logistics and personnel movements on its primary transport route in Mozambique
- Syrah suspended travel on the road for a week due to security concerns in Cabo Delgado province, about 200km from the Balama Mine
- Balama operations were not affected by the travel restrictions and have continued as normal.

Syrah Resources Limited (ASX: SYR) ("Syrah" or the "Company") advises Balama logistics and personnel movements will recommence, following a review of security with contractors and other key stakeholders.

Mining and processing at Balama were not affected by the temporary suspension of logistics and personnel movement.

Syrah and its logistics service provider have lifted the precautionary suspension of personnel and logistics movements based on direct monitoring and security assessments from qualified third parties, effective immediately. The N1 road has remained open through this period and is a key priority for Government and Security authorities.

Syrah suspended travel on the N1 road following reported security incidents occurred approximately 200km from the Balama Mine in Cabo Delgado province, and no Balama employees or contractors were impacted.

Syrah continues to maintain close contact with the Mozambique government, security authorities and other stakeholders to monitor security in the region and ensure the safety of its employees and contractors.
