AFC 2018-1 Trust consists of Class A Notes amounting to \$21.25 million, with a maturity in October 2023 and carrying interest of 6.20%. AFC 2019-1 Trust consists of Class A and Class B Notes amounting to \$31.89 million and \$4.36 million respectively, together totalling \$36.25 million and with a maturity in July 2025. Class A and Class B Notes carried an interest of 8.00% and 12.00% respectively to 30 June 2022, after which the rate reduced to 7.25% and 10.25% respectively. The AFC 2018-1 Trust and AFC 2019-1 Trust are secured against the funded receivables. (b) An unsecured loan from Action Funding (Aust) Pty Ltd, a related party, amounting to \$0.82 million, maturing after July 2023 and which does not accrue interest.
