## **Extension of time to hold AGM and ASX Appendix 4G**

**Melbourne, 22 July 2022:** PayGroup Limited (“**PayGroup**” or the “**Company**”), a leading provider of enterprise payroll and human capital management (HCM) solutions advises that it has received consent from ASIC to extend the time within which it must hold its Annual General Meeting for FY2022 by one month to on or before 30 September 2022.

The reasons for the extension are as follows:

1. On 23 June 2022 Paygroup announced a proposed scheme of arrangement whereby its issued capital is to be acquired by Deel, Inc. (“**Scheme**”);
2. It is not possible to hold the first Scheme meeting proscribed by the Corporations Act within the current 5 months prescribed to hold the Paygroup 2022 AGM, being on or before 31 August 2022;
3. Paygroup believes it is desirable for its shareholders to hold the 2022 AGM immediately prior to the Paygroup scheme meeting, for the following reasons:
  - a. It reduces Paygroup costs in that there will be only one mail out of documents and reduced management time;
  - b. It avoids confusion in Paygroup shareholders otherwise receiving an AGM notice when they may be expecting the Scheme notice of meeting;
  - c. The Paygroup board composition (which is as usual an item of business for the AGM) would in any event change should the Paygroup shareholders approve the proposed Paygroup scheme;
  - d. Paygroup shareholders will have all information before them relevant to the proposed shareholder resolutions as they will be in receipt of the Scheme Booklet;
  - e. The extension of time requested is relatively short and there is no discernible prejudice to Paygroup shareholders as they already have access to the audited FY22 Financial Report to be considered at the AGM, and will be better informed at that meeting if they are given access to the Scheme Booklet.

Paygroup will advise the market once the date for the AGM and first shareholder meeting for the Scheme has been set.
