<p>\$2,950,000 was raised through the issue of Secured Convertible Notes on 7th December 2018 to Thundering Herd Fund No.1 and Thundering Herd Pty Ltd with an annual coupon of 15% payable quarterly in arrears. On 18th May 2020 the maturity date was extended by 1 year to 7th December 2021. On 22nd July 2021 the maturity date was further extended to 1 July 2022. Subsequently, with an effective date of 22nd December 2021, the maturity date was further extended to 1st February 2023. The extension was subject to conditions precedent that DomaCom is currently addressing.</p> <p>\$650,000 was raised through the issue of Unsecured Convertible Notes on 25th January 2018 to various note holders with an annual coupon of 10% payable quarterly in arrears. On 18th May 2020 the maturity date was extended by 1 year to 25th January 2022. The Unsecured Convertible Notes are subject to a subordination agreement and will therefore not be repaid prior to the Secured Convertible Notes.</p>
