## **Notification of Expiry of Listed Options**

WCM Global Growth Limited (**WQG** or the **Company**) advises that the attached letter has been sent to registered holders of listed options (ASX: WQGOA) (**Options**) which are exercisable at \$1.50 on or before 5pm (AEST) on 31 August 2022 (**Expiry Date**).

Official quotation of the listed Options will cease at the close of trading on 25 August 2022, being four business days before the Expiry Date. Holders of the Options can exercise all or part of their Options prior to the Expiry Date by providing the Company with a completed Notice of Exercise of Options from specifying the number of Options being exercised and a payment of funds for the total exercise price for the number of Options being exercised.

## EXPIRY OF OPTIONS (ASX: WQGOA) (Options)

You are the registered holder of the above-mentioned listed Options in WCM Global Growth Limited (**WQG** or the **Company**) expiring on 31 August 2022.

- These Options entitle you to acquire one fully paid ordinary share in the capital of WQG for each Option you choose to exercise. The Company presently has a total of 49,651,668 Options.
   Assuming the exercise of all WQG's Options, the Company's fully diluted issued capital would be 235,638,002 shares.
- 2. The exercise price of these Options is A\$1.50 each.
- 3. The due date for payment is 5.00pm AEST on 31 August 2022 (Due Date).
- 4. There is no obligation upon the holder to exercise their Options, however if payment is not received by the Due Date the Options will lapse and all rights under the Options will cease at that time.
- 5. The Options will cease to be quoted on ASX from close of trading on 25 August 2022.
- 6. The closing market price of ordinary fully paid shares in WQG on Australian Securities Exchange (ASX) was \$1.23 on 11 August 2022, being the last trading day in WQG prior to the dispatch of this letter.
- 7. During the three months preceding the date of this notice the highest market price of ordinary fully paid shares in WQG on the ASX was \$1.27 on 2 August 2022, and the lowest market price was \$1.08 on 14 June 2022 within that three month period.
- 8. As at the date of this notice, there are no underwriting agreements in relation to the Options.

The Company will be releasing its results for the year ended 30 June 2022 on 19 August 2022 during the period leading up to expiry of the Options.

If you wish to exercise your Options, then you must complete a Notice of Exercise of Options form and forward it together with payment of \$1.50 per Option exercised to be received no later than 5.00pm AEST on 31 August 2022 to the Company's share registrar Link Market Services, Level 12, 680 George Street, Sydney NSW 2000.
