Update on Baúna Intervention Campaign

Karoon reports that the second well intervention, comprising the installation of gas lift in well SPS-56, has been completed and the well brought back on line. Oil production from the well is currently approximately 3,700 bopd, compared with approximately 750 bopd prior to the commencement of the intervention. Production from well PRA-2, which was the first well intervention, currently remains stable at approximately 4,000 bopd, as previously announced.

The third well intervention, to install a new electric submersible pump in well SPS-92, is underway and is currently expected to be completed in late September.
