TRADING HALT REQUEST – DOTZ NANO LIMITED (ASX: DTZ)

Dotz Nano Limited ("**DTZ**" or the "**Company**") hereby requests a trading halt in respect of its fully paid ordinary shares (**ASX: DTZ**) pursuant to ASX Listing Rule 17.1.

For the purposes of ASX Listing Rule 17.1, and in support of its request, DTZ advises that:

- (a) The trading halt is necessary as DTZ expects to make an announcement to the ASX in connection with the finalising of a proposed placement with a U.S. based institutional fund;
- (b) DTZ requests that trading in its securities be halted until after the expected announcement is made or until the market opens on Thursday, 15 September 2022, whichever is the earlier; and
- (c) DTZ is not aware of any reason why this trading halt request should not be granted.
