## **Extension of Share Purchase Plan**

### **Highlights:**

- Extension of Wellnex Life Share Purchase Plan, with revised closing date to be Monday 17<sup>th</sup>
  October at 5pm (AEDT).
- Funds raised will be used to progress the JV with OneLife Botanicals with the goal to be one of the
  first companies to offer an over-the-counter medical cannabis product in the Australian market,
  finance the inventory required for launching new products including Performance Inspired and
  Pharmacy Own and continue to progress further growth avenues such as its own ecommerce
  channel, and cover the cost of the capital raise.

**Wellnex Life Limited (ASX: WNX)**, brand and distribution company of customer-focused health and wellness products, advises that the closing date for the Share Purchase Plan (SPP) announced to the market on 13 September 2022 will be extended from Wednesday, 5 October to Monday, 17 October at 5pm (AEDT).

The Board has made the decision to extend the SPP closing date to allow eligible shareholders additional time to submit applications and arrange settlement in light of recent public holidays and postal delays.

Under the SPP new fully paid ordinary shares will be issued at \$0.075 per share, representing a discount of approximately 19.70% to Wellnex's VWAP over the last five days on which sales in Shares were recorded, before the SPP announcement date of 13 September 2022.

The SPP offers shareholders who were registered holders of Shares as at 7:00pm (Melbourne time) on Monday 12 September 2022 (Record Date), with a registered address in Australia or New Zealand (Eligible Shareholders), the opportunity to apply for up to A\$30,000 of new Shares (New Shares).
