

# SXG DRILLS FIRST HOLE UNDER GOLDEN DYKE: 48.9 m @ 3.0 g/t AuEq NEW ZONE FROM YET ANOTHER STEP OUT AT SUNDAY CREEK

#### **20 OCTOBER 2022**

Melbourne, Australia — Southern Cross Gold Ltd ("SXG" or the "Company") (ASX:SXG) is pleased to announce further high-grade drill results from the 100%-owned Sunday Creek project in Victoria (Figure 1).

Drillhole SDDSC049, drilled below old workings at Golden Dyke for the first time, intersected **48.9 m** @ **3.0 g/t AuEq** (2.0 g/t Au, 0.64% Sb) from 182 m (no lower cut) in a new shoot with wide zones of mineralisation and seven high-grade intersections (>10 g/t AuEq) grading up to 38.2 g/t AuEq (34.0 g/t Au and 2.67% Sb) and with abundant visible gold (Photos 1- 3).

This is an extremely significant result as it demonstrates both a new area beneath the Golden Dyke historic mine area and that multiple mineralised areas have now been drilled by SXG over a 700 m strike at Sunday Creek. This follows drill hole SDDSC045¹ (89.5m @ 1.9 g/t AuEq including 3.8 m @ 28.9 g/t AuEq) reported by the Company on Monday 17 October, which was located 525 metres east at Apollo. Two drillholes are reported here (SDDSC047/49).

#### **HIGHLIGHTS**

- Drill hole SDDSC049, a 550 m step out along strike to the west of Apollo and 210 m from Rising Sun, and one of the first holes to drill under the most productive historic mining areas (Golden Dyke) at Sunday Creek intersected 48.9 m @ 3.0g/t AuEq (2.0 g/t Au, 0.64% Sb) from 182 m (no lower cut) (Figure 3). Higher grade zones included:
  - o **1.4 m @ 6.8 g/t AuEq** (0.3 g/t Au, 4.09% Sb) from 195.8 m, including
    - **0.4 m @ 22.97 g/t AuEq** (0.7 g/t Au, 14.10% Sb) from 195.8 m
  - 13.7 m @ 9.4 g/t AuEq (6.6 g/t Au, 1.79% Sb) from 201.3 m, including
    - **2.7 m @ 20.9 g/t AuEq** (10.4 g/t Au, 6.59% Sb) from 204.4 m
    - **2.3 m @ 27.9 g/t AuEq** (24.7 g/t Au, 2.01% Sb) from 211.0 m
- Drill hole SDDSC047, drilled 30 m east of SDDSC049 intersected lower grade mineralisation (Figure 3):
  - o 10.2 m @ 0.9 g/t AuEq (0.9 g/t Au, 0.01% Sb) from 192.8 m, including
    - **0.3 m @ 5.1 g/t AuEq** (5.1 g/t Au, 0.02% Sb) from 197.8 m
- SXG is drilling three areas along a 700 m strike of known surface mineralisation, with the
  deepest drilling to date undertaken, and has two hole pending assays and two holes in
  progress. Of particular interest is drill hole SDDSC050, designed to drill the Rising Sun shoot
  in a previously untested west to east orientation.

**SXG's Managing Director, Michael Hudson says,** "Over the last two weeks we have tripled the extent of high-grade zones drilled at Sunday Creek and SDDSC049 delivers yet another >100 g/t x m AuEq, with 19 drillholes now exceeding this threshold on the project – an exceptional hit rate.

"Sunday Creek keeps on beating expectations with high grade mineralisation now identified in our first drilling under the most productive historic mine on the project at Golden Dyke. With three high grade areas now drilled over a 700 m strike at Golden Dyke, Rising Sun and Apollo we are witnessing the unveiling of a significant mineral system that keeps on delivering grade, scale and width in spades."

#### **Drill Hole Discussion**

This was SXG's first drill test under the most productive historic mining area (Golden Dyke) at Sunday Creek. This is an extremely significant result as it demonstrates that multiple mineralised areas exist over a 700 m strike, including:

- Golden Dyke drill hole SDDSC049 reported here: 48.9 m @ 3.0g/t AuEq (2.0 g/t Au, 0.64% Sb) from 182 m (no lower cut) including 13.7 m @ 9.4 g/t AuEq (6.6 g/t Au, 1.79% Sb) from 201.3 m.
- Rising Sun, drill hole SDDSC046<sup>1</sup> located 210 m east from SDDSC049: 21.5 m @ 15.0 g/t AuEq (12.2 g/t Au and 1.7% Sb), and
- Apollo, drill hole SDDSC033<sup>1</sup> located 550 m east from SDDSC049: 119.2 m @ 3.2 g/t Au and 0.4% Sb (3.9 g/t AuEq).

Historic drilling extends mineralisation 500 m west of Golden Dyke to the historic Christina mine and completely undrilled areas 10 km NE through historic mining areas at Leviathan, Consols, Aftermath and Tonstal, all held within SXG 100% exploration tenure (Figure 2).

SDDSC049<sup>1</sup> was drilled 35 m beneath historic workings at Golden Dyke and 160 m below shallow historic drill hole CRC020<sup>1</sup> **54.0 m @ 1.9 g/t AuEq** (1.5 g/t Au, 0.3% Sb) from 0 m, including **3.0 m @ 17.9 g/t AuEq** (16.2 g/t Au and 1.1% Sb).

SDDSC047 drilled 30 m east of SDDSC049 and also reported here, demonstrates a wide zone of arsenic anomalism from 177.6 m to 206 m (28.4m), with lower grade gold including **10.2 m @ 0.9 g/t AuEq** (0.9 g/t Au, 0.01% Sb) from 192.8 m, including **0.3 m @ 5.1 g/t AuEq** (5.1 g/t Au, 0.02% Sb) from 197.8 m and is considered a near miss.

Mineralised shoots at Sunday Creek are formed at the intersection of the sub-vertical to shallower dipping 330 degree striking mineralised veins and a steep east-west striking, north dipping structure hosting dioritic dykes and related intrusive breccias. The dimensions of each shoot will be uncovered with further drilling, but typically:

- In the down plunge orientation (80 degrees towards trend of 020 degrees), high grades show a linear continuity to at least 400 m from surface and remain open.
- **20 m to 30 m** wide in the up-dip/down-dip orientation but can blow out to be wider (i.e. around SDDSC033), and;
- A true thickness of up to 50 m, with higher grades between 20 m and 40 m in the cross section of the shoot but further drilling will be required to establish a more accurate average.

#### **Update on Current Drilling**

Drilling with two rigs continues at Sunday Creek at Apollo and Rising Sun (located 400 m to the west of Apollo). Further drilling will now be prioritised at Golden Dyke (located 700 m west of Apollo). Two holes (SDDSC048A/51) are being geologically processed and analysed, with two holes (SDDSC050/52) remaining in drill progress (Figure 3).



Of particular interest is drill hole SDDSC050, designed to drill the Rising Sun shoot in a previously untested west to east orientation. A preliminary visual geological log of SDDSC050 indicates the Rising Sun shoot was intersected around 350 m with multiple zones of mineralisation occurring from 393 to 590 m with visible gold noted in certain restricted zones. This appears to be the thickest intersection of mineralisation seen to date, pending assays. The hole remains in progress.

Figures 1-4 show project location and plan, longitudinal and cross section views of drill results reported here and Tables 1–3 provide collar and assay data. The true thickness of the mineralised intervals is interpreted to be approximately 60 % - 70 % of the sampled thickness of high-grade mineralisation. All drill results quoted have a lower cut of 0.3 g/t Au cut over a 3.0 m width, with higher grades reported with a 5 g/t Au cut over 1.0 m, unless otherwise indicated.

# **Geological and Scale Comparison to Other Victorian Epizonal Deposits**

The Company considers Sunday Creek to have the potential to be a truly significant exploration discovery in Victoria with nineteen (19) >100 cumulative grade x metres ("AuEq g/t x m") holes now intersected.

Sunday Creek has a 10 km mineralised trend that extends beyond the drill area and is defined by historic workings and soil sampling which have yet to receive any exploration drilling and offers potential future upside.

The Sunday Creek epizonal-style gold project is located 60 km north of Melbourne within 19,365 hectares of granted exploration tenements. SXG is also the freehold landholder of 132.64 hectares that forms the key portion in and around the drilled area at the Sunday Creek Project.

Geologically, the project is located within the Melbourne Structural Zone in the Lachlan Fold Belt. The regional host to the Sunday Creek mineralisation is an interbedded turbidite sequence of siltstones, minor sandstones metamorphosed to sub-greenschist facies and folded into a set of open NW trending folds. Mineralisation at Sunday Creek is controlled by veining, stibnite-gold-matrix breccias and brittle faults. The immediate host for mineralisation is a zone of intensely altered white mica-pyritic siltstones, and white mica-pyrite-carbonate altered dyke rocks.

As is typical for epizonal deposits like Fosterville and Costerfield, gold (locally visible) at Sunday Creek is hosted in quartz and carbonate veins, with a later intense stibnite-bearing vein and breccia overprint. A larger arsenic anomaly is associated with the gold mineralisation, mostly represented by arsenian-pyrite but developing to arsenopyrite-bearing zones with a clear spatial relationship to high-grade gold.

## **Further Discussion**

# **Critical Metal Epizonal Gold-Antimony Deposits**

Sunday Creek (Figure 1) is an epizonal gold-antimony deposit formed in the late Devonian (like Fosterville, Costerfield, Redcastle and Whroo), 60 million years later than mesozonal gold systems formed in Victoria (for example Ballarat and Bendigo). Epizonal deposits are a form of orogenic gold deposit classified according to their depth of formation: epizonal (<6 km), mesozonal (6-12 km) and hypozonal (>12 km).

Epizonal deposits in Victoria often have associated high levels of the metal, antimony, and Sunday Creek is no exception. Geoscience Australia reported that as at 2019, antimony is a critical metal where China and Russia combined produce approximately 82% of the antimony raw material supply. Antimony features highly on the critical minerals lists of many countries including Australia, the United States of America, Canada, Japan and the European Union. Australia ranks seventh for antimony production despite all production



coming from a single mine at Costerfield in Victoria, located nearby to all SXG projects. Antimony alloys with lead and tin which results in improved properties for solders, munitions, bearings and batteries. Antimony is a prominent additive for halogen-containing flame retardants. Adequate supplies of antimony are critical to the world's energy transition, and to the high-tech industry, especially the semi-conductor and defence sectors. For example, antimony is a critical element in the manufacture of lithium-ion batteries and to the next generation of liquid metal batteries that lead to scalable energy storage for wind and solar power.

## **Gold Equivalent Calculation**

SXG considers that both gold and antimony that are included in the gold equivalent calculation ("AuEq") have reasonable potential to be recovered at Sunday Creek, given current geochemical understanding, historic production statistics and geologically analogous mining operations. Historically, ore from Sunday Creek was treated onsite or shipped to the Costerfield mine, located 54 km to the northwest of the project, for processing during WW1. The Costerfield mine corridor, now owned by Mandalay Resources Ltd contains 2 million ounces of equivalent gold (Mandalay Q3 2021 Results), and in 2020 was the sixth highest-grade global underground mine and a top five global producer of antimony.

SXG considers that it is appropriate to adopt the same gold equivalent variables as Mandalay Resources Ltd in its <u>Mandalay Technical Report, 2022</u> dated 25 March 2022. The gold equivalence formula used by Mandalay Resources was calculated using recoveries achieved at the Costerfield Property Brunswick Processing Plant during 2020, using a gold price of US\$1,700 per ounce, an antimony price of US\$8,500 per tonne and 2021 total year metal recoveries of 93% for gold and 95% for antimony, and is as follows:  $AuEq = Au (g/t) + 1.58 \times Sb$  (%).

Based on the latest Costerfield calculation and given the similar geological styles and historic toll treatment of Sunday Creek mineralisation at Costerfield, SXG considers that a  $AuEq = Au (g/t) + 1.58 \times Sb$  (%) is appropriate to use for the initial exploration targeting of gold-antimony mineralisation at Sunday Creek.



Figure 1: Location of the Sunday Creek project, along with SXG's other Victoria projects.






Figure 2: Location of the Sunday Creek drill area at Golden Dyke – Rising Sun -Apollo, showing undrilled 10 km extension to the north-east with historic mines and gridded gold in soil geochemistry.




Figure 3: Sunday Creek plan view showing drillholes for results reported in this announcement, prior reported drill holes 1 and pending holes. SDDSC046 MDDSC025 MDDSC021 21.5 m @ 15.0 g/t AuEq 11.7 m @ 18.0 g/t AuEq 21.7 m @ 6.2 g/t AuEq incl. Incl. incl. 2.1 m @ 121.6 g/t AuEq 0.5 m @ 21.2 g/t AuEa 0.4 m @ 177.1 g/t AuEq MDDSC026 5.6 m @ 10.5 g/t AuEq incl. 0.9 m @ 52.8 g/t AuEq SDDSC050 SDDSC051 Golden Dyke SDDSC052 **Longitudinal Section Rising Sun** Gladys Along Dyke CRC020 54.0 m @ 1.9 g/t AuEq incl. 3.0 m @ 17.9 g/t AuEq Apollo SDDSC047 10.2 m @ 0.9 g/t AuEq SDDSC049 incl. 48.9 m @ 3.0 g/t AuEq 0.3 m @ 5.1 g/t AuEq incl. 2.7 m @ 20.9 g/t AuEq 100 m 2.3 m @ 27.9 g/t AuEq SDDSC033 119.2m @ 3.9 g/t AuEq 1.0m @ 5g/t AuEq lower cut SDDSC048 incl. 64.0 m @ 3.0 g/t AuEq and 3.0m @ 0.3 AuEq g/t lower cut Drill hole with assay pending Host dyke and intrusive breccias **SOUTHERN** CROSS (dips steeply north) GOLD


