

# Syrah enters into MOU with LG Energy Solution

## **Highlights**

- Syrah enters into a non-binding memorandum of understanding with LG Energy Solution, a leading global manufacturer of lithium-ion batteries
- Syrah and LG Energy Solution will evaluate natural graphite active anode material ("AAM") supply from the Vidalia AAM facility in USA.

Syrah Resources Limited (ASX:SYR) ("Syrah" or "Company") announces it has entered into a non-binding memorandum of understanding ("MOU") with LG Energy Solution, Ltd. (KRX: 373220) ("LG Energy Solution") to evaluate natural graphite active anode material ("AAM") supply from Syrah's vertically integrated Vidalia AAM facility in Louisiana, USA ("Vidalia").

Under the MOU, Syrah and LG Energy Solution will continue testing and qualifying Vidalia AAM and use commercially reasonable efforts to finalise, by no later than 31 December 2022, a binding offtake agreement for 2ktpa AAM from Vidalia commencing from 2025 and increasing to at least 10ktpa AAM upon Vidalia's expansion to a 45ktpa AAM production capacity. Syrah and LG Energy Solution will continue to co-operate to expand Vidalia AAM volumes and support the growing electric vehicle market.

Syrah is developing Vidalia as a vertically integrated natural graphite AAM supply alternative for USA battery supply chains with start of production of a 11.25ktpa AAM facility targeted in the September 2023 quarter. A Definitive Feasibility Study ("DFS") on the expansion of Vidalia's production capacity to at least 45ktpa AAM, inclusive of 11.25ktpa AAM, is underway. Detailed engineering, procurement, and construction phases for the subsequent expansion of Vidalia will follow the DFS sequentially, subject to Syrah Board approval and customer and financing commitments.
