

## Notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth)

MELBOURNE, 28 November 2022: This notice is given by TALi Digital Limited (ASX: TD1) (ACN 108 150 750) (**TALi** or **Company**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (the **Act**).

TALi has today issued 125,000,000 fully paid ordinary shares (**New Shares**) at an issue price of \$0.002 per New Share pursuant to a strategic placement to Sprint Capital Partners Pty Ltd announced to ASX on 21 November 2022.

For the purposes of section 708A(6) of the Act, the Company hereby notifies ASX that:
