Future First Technologies Ltd (ASX: FFT) (**FFT** or the **Company**) advises that it has issued a combined total of 20,000,000 Unlisted Options to the Directors in line with shareholder approval obtained at the General Meeting of shareholders held on 18 November 2022:

- a) 10,000,000 options with an exercise price of five cents (\$0.05) with a two-year expiry;
- b) 10,000,000 options with an exercise price of ten cents (\$0.10) with a three-year expiry; and
- c) The options will be exercisable in 2 tranches of 10,000,000 each on, as to the options exercisable for \$0.05 on or before 14 August 2024, and as to the options exercisable for \$0.10 on or before 14 August 2025.

The options are issued as part of an initiative to encourage long-term retention of Directors along with the alignment of the interests of delivering shareholder returns.
