Answer: No. The Company accelerated the exploration program on Millennium to reach the Stage 1 earn-in expenditure and with MBK now holding 51% of the Joint Venture with Global Energy Metals Corporation (see ASX announcement dated 5 December 2022).

Answer: The Company is evaluating various options to advance its key projects, and has been successful in raising capital in previous years.
