No the Company is reviewing operations to minimise costs and optimise revenues in the context of modest iron ore production and a growing business in waste material a significant volume of which is already processed or requires minimal processing for sale.

Since the end of the quarter the Company has raised \$75,000 via convertible debt and is in active discussion with multiple investors and anticipates raising additional capital.

Yes. The Company is reviewing operations to minimise costs and optimise revenues, continues to supply to existing customers and proposes to raise additional capital during the current quarter.
