# **Invitation to Participate in Share Purchase Plan**

On 30 January 2023, Enegex Limited (**Enegex**) announced the launch of a Share Purchase Plan (**SPP**) to fund its ongoing activities including exploration work at its West Yilgarn Ni-Cu-PGE projects.

The SPP provides an opportunity for eligible shareholders to subscribe for up to \$30,000 of new shares in Enegex. New Shares will be issued at the issue price of \$A0.03 (3 cents), together with a free unlisted option (exercisable at \$0.05 (5 cents) on or before 31 January 2026) on the basis of one option to be granted for every two shares issued.

Enegex has decided to undertake the SPP in order to enable shareholders to support its ongoing activities including to progress its exploration programs aimed toward defining drill targets. Enegex is one of the largest tenement holders in the West Yilgarn province which is recognised as an endowed Ni-Cu-PGE terrain following the discovery by Chalice Mining of the nearby Tier 1 Gonneville Ni-Cu-PGE Resource at Julimar and presents opportunity for multiple regional discoveries.

# **Shareholders Eligible to Participate in the Plan**

Participation under the Plan is optional and is available exclusively to shareholders of the Company who are registered as holders of Shares at **5.00pm (AEDT)** on **27 January 2023** (**Record Date**) and whose registered address is in Australia or New Zealand (**Eligible Shareholders**).

# **Share Purchase Plan**

The Plan entitles Eligible Shareholders, irrespective of the size of their shareholding, to purchase up to \$30,000 worth of shares at an issue price of \$0.03 (3 cents) (**Price**) per share together with a free 1 for 2 unlisted option, exercisable at \$0.05 (5 cents) on or before 31 January 2026.

Depending on applications received, the Company may, in its absolute discretion, undertake scale backs. Scale back decisions are made by the Board and are final.

The directors of the Company who are Eligible Shareholders may participate under the Plan.

The Company's Chairman, Mr Geoff Albers, has indicated that he will participate in the SPP to the extent of his personal shareholding.

### **Current Activities**

The Company is exploring for Ni-Cu-PGE, with a focus on its West Yilgarn projects. With five project areas spanning 2,942km<sup>2</sup>, Enegex is one of the largest tenement holders in the Julimar district of the recently recognised West Yilgarn Ni-Cu-PGE province and is strategically positioned with opportunity for multiple regional discoveries.

#### **Use of Funds**

The proceeds raised under the Plan will be used to fund Enegex's activities including its forward exploration programs.

# Relationship of Issue Price with Market Price

The market price of Shares in the Company may rise and fall between the date of the Offer and the date that any Shares are issued to you as a result of your Application under this Offer.

By making an Application under this Offer and applying for Shares under the Plan, each Eligible Shareholder will be acknowledging that although the Price is at a discount, Shares are a speculative investment and the price of Shares on ASX may change between the date of the Company announcing its intention to make an Offer and the date of issue of Shares under that Offer and that the value of the Shares received under the Plan may rise or fall accordingly.

The Board recommends that you obtain your own financial and taxation advice in relation to the Offer and consider price movements of Shares in the Company prior to making an Application under this Offer.

# **Additional Information and Important Dates**

The offer of Securities under the Plan is made in accordance with ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547 and therefore does not require a prospectus for the purposes of Chapter 6D of the Corporations Act 2001 (Cth).

The Offer cannot be transferred. The Directors of the Company reserve the right in their absolute discretion to reject, or scale back, on an equitable basis, any Application. Shares issued under the Plan will be issued no later than 7 business days after the Closing Date of the Offer with options granted on the same day.

Application for quotation on ASX of the new shares will be made immediately following the issue of those shares. The options will be unlisted.

The maximum amount sought to be raised under the Offer is \$1,013,496.

In the event of oversubscription by the Closing Date, the Directors may, in their absolute discretion, scale-back applications on an equitable basis. Scale-back for shares held by Custodians will be applied at the level of the underlying Beneficiary.

If the Company rejects or scales-back an Application or purported application, the Company will promptly return the relevant Application monies to the shareholder, without interest.

# **Enegex Limited Share Purchase Plan - Terms and Conditions**

# **Purpose**

The purpose of the Share Purchase Plan (**the Plan**) is to offer shareholders of Enegex Limited (**Company**) the opportunity to acquire additional fully paid ordinary shares in the Company (**Shares**) up to a maximum of \$30,000 and a minimum of \$2,000 worth of Shares.

The issue price of \$0.03 (3 cents) under the Plan is a discount of 17.59% to the volume weighted average market price of the Shares over the last 5 trading days on which sales in the Shares were recorded prior to the date the Plan was announced.

Unlisted options will be granted without cost on the basis of one option for every two shares subscribed, thus enabling the purchase of additional shares at \$0.05 (5 cents) on or before 31 January 2026.

The maximum amount that may be raised under the Plan is \$1,013,496. The Shares will not attract brokerage costs and will be issued without the need for the Company to issue a prospectus. The Plan is governed upon such terms and conditions as the board of directors of the Company, in its absolute discretion, sees fit.

Due to foreign securities laws, it is not practical for shareholders (or beneficial shareholders) resident in other countries to be offered the opportunity to participate in the Plan.
