REQUEST FOR TRADING HALT

Hydrix Limited (ASX: **HYD**) (the **Company**) requests a halt to the trading of the Company's quoted securities on the Australian Securities Exchange (**ASX**) in accordance with ASX Listing Rule 17.1, effective from the commencement of trading today, 13 February 2023.

In accordance with Listing Rule 17.1, the Company provides the following information in relation to the request:

1. The Company is seeking a trading halt pending an announcement to the market in relation to the regulatory approval status of the AngelMed Guardian Device (**Announcement**).
2. The Company requests that the trading halt remains in place until the earlier of the Company releasing the Announcement, or the commencement of normal trading on Wednesday 15 February 2023.
