Dear Option Holder.

NOTIFICATION OF EXPIRY OF OPTIONS

At the date of this notice, you are a registered holder of unlisted options (the Options, ASX code: OXXOPT1) in Octanex Limited (the Company, ASX code: OXX)

You are encouraged to read this letter carefully and in full and if you are unsure about what to do with your Options then you should seek advice from your accountant, stockbroker, lawyer, licensed financial adviser or other professional adviser.

This letter notifies you of the impending expiry of the Options on 30 April 2023. It also sets out your alternative courses of action prior to expiry and provides information about recent prices of Octanex shares and the Options.

Your choices as an Option holder are:

(7.5 cents) will lapse.

Do nothing and allow your Options to lapse If you do not take any action to exercise your Options prior to 5:00pm (Melbourne time) on 30 April 2023, the Options will expire and your right to purchase shares at \$0.075

Exercise all or some of your Options

To exercise your Options, the enclosed Options Expiry Notice and your cleared funds must be received by the Company no later than 5:00pm (Melbourne time) on Friday. 28 April 2023. Note that exercising your options does not incur any brokerage costs.

The Company advises the following:

- a) Attached is your Options Expiry Notice.
- b) Each Option entitles the holder to receive, on exercise, one fully paid ordinary share in the Company. If all Options are exercised, by all holders of the Options, then 7,500,000 fully paid ordinary shares will be issued.
- c) The exercise price of the Options is \$0.075 (7.5 cents) per share. If cleared funds are not received by 5:00pm (Melbourne time) on Friday, 28 April 2023, then your Options will expire with no value and no further entitlement will exist.
- d) The last available market price of OXX shares prior to the date of this notice was \$0.006 (0.6 of one cent) at the close of trading on 15 March 2023.



e) The highest and lowest market prices of OXX shares traded in the three months immediately before the date of this notice were:

f) The Company's shares were suspended from quotation on 16 March 2023 under Listing Rule 17.3
