Telix's lead product, gallium-68 (<sup>68</sup>Ga) gozetotide (also known as <sup>68</sup>Ga PSMA-11) injection, has been approved by the U.S. Food and Drug Administration (FDA),<sup>1</sup> and by the Australian Therapeutic Goods Administration (TGA),<sup>2</sup> and by Health Canada.<sup>3</sup> Telix is also progressing a marketing authorisation application for this investigational candidate in the United Kingdom.<sup>4</sup>
