#### **About Gyder Surgical**

Gyder is an Australian medtech company specialising in non-invasive orthopaedic navigation solutions. The GYDER® Hip Navigation System is a computer controlled, non-invasive surgical tool to aid navigation during total hip arthroplasty via the anterior approach. It is designed to provide real-time guidance and assist the surgeon in positioning the acetabular cup in the intended orientation during primary or revision total hip arthroplasty. Incorrect positioning of the acetabular cup during total hip replacement can lead to potential dislocations, cup loosening ultimately leading to failures, impingement, excessive liner wear & osteolysis, limited range of motion, abnormal gait, and limb length. Improved cup placement accuracy has significant potential to reduce post-surgery complications, thereby improving patient outcomes and lowering health system cost burden. The system is an open system that provides surgeons flexibility to use their preferred implant system.
