EBR Unlocks Second Tranche of Growth Capital Facility

Sunnyvale, California; 6 June 2023: EBR Systems, Inc. (ASX: **"EBR"**, **"EBR Systems"**, or the **"Company"**), developer of the world's only wireless cardiac pacing device for heart failure, is pleased to announce that Runway Growth Capital has confirmed access to the second tranche of EBR's growth capital facility.

EBR first executed an agreement for a 5-year US\$50m growth capital facility with leading venture debt provider Runway Growth Capital on 1 July 2022. The facility is structured over three separate tranches, with the first US\$20m tranche being granted upon execution of the agreement. EBR has now confirmed that the second tranche of up to US\$20m has been unlocked given the positive SOLVE-CRT trial data announced 22 May 2023.

The second tranche of the facility provides further non-dilutive funding flexibility and will support growth activities as the Company finalises its PMA submission in Q1 2024 and begins to execute on its commercialisation strategy, targeting key high-volume CRT procedure sites in the US.

John McCutcheon, President and CEO of EBR Systems commented:

"We are delighted that Runway Growth Capital has confirmed that EBR has met the milestones to unlock the second tranche of our growth capital facility following the announcement of our positive SOLVE-CRT trial results. As per the agreement, we now have the option to access up to US\$20m on or before 30 June 2023. This would add further flexibility to our balance sheet as we prepare the final stages of our FDA submission and commercialisation. Runway Growth Capital continue to be a strong supporter of our Company, sharing our vision for cardiac rhythm disorder treatments and helping to bring our ground-breaking technology to heart failure patients worldwide."

Silicon Valley-based EBR Systems (ASX: EBR) is dedicated to superior treatment of cardiac rhythm disease by providing more physiologically effective stimulation through wireless cardiac pacing. The patented proprietary Wireless Stimulation Endocardially (WiSE) technology was developed to eliminate the need for cardiac pacing leads, historically the major source of complications and reliability issues in cardiac rhythm disease management. The initial product is designed to eliminate the need for coronary sinus leads to stimulate

the left ventricle in heart failure patients requiring Cardiac Resynchronisation Therapy (CRT). Future products potentially address wireless endocardial stimulation for bradycardia and other non-cardiac indications.

EBR Systems' WiSE® Technology

EBR Systems' WiSE technology is the world's only wireless, endocardial (inside the heart) pacing system in clinical use for stimulating the heart's left ventricle. This has long been a goal of cardiac pacing companies since internal stimulation of the left ventricle is thought to be a potentially superior, more anatomically correct pacing location. WiSE technology enables cardiac pacing of the left ventricle with a novel cardiac implant that is roughly the size of a large grain of rice. The need for a pacing wire on the outside of the heart's left ventricle – and the attendant problems – are potentially eliminated. WiSE is an investigational device and is not currently available for sale in the US.
