#### Company Update

Broo Limited (ASX:BEE) (the **Company**) is pleased to provide the following company update to the market.

#### **Status of FY22 Full Year Audit & 1H FY23 Half Year Audit Review**

The Company has now commenced the preparation of audit of full year accounts for the period ended 30 June 2022 (**Full Year Audit**) and audit review of the half year accounts for the period ended 31 December 2022 (**Half Year Audit Review**). It is expected that the Full Year Audit and Half Year Audit Review will be completed in the coming weeks, after which the Company will release the audited full year accounts for FY22 and reviewed half year accounts for 1H 23 to the ASX.

#### **Status of Voluntary Administration of Subsidiaries**

The Company is also pleased to update to the market that the voluntary administration process for certain Broo subsidiaries (as announced to the ASX on 24 June 2022) is at the final stage and the Company expects to provide an update to the market on the outcome of this in due course.

#### **Business Update**

Following the appointment of the new Chair Mr Jiawei Chen (as announced to ASX on 31 May 2023), the Board has decided to broaden the current product category offering to cover mid-strength beer, craft beer and zero percent alcohol drinks on top of the existing product range. The rationale for this strategy is aimed at increasing profit margin as a result of lower taxes applied to these products as well as the ability to focus on a broader consumer base.

In addition, the Company is exploring additional domestic and international distribution channels for the sale of Broo products. The Company will provide further market update once parties reach agreement on commercial terms.

The Company's shares currently remain in voluntary suspension. It will consult with the ASX for reinstatement of its shares in due course.
