Four NED RTD SKUs and the 700ml glass have been added to the Endeavour dark spirits range following its annual reviews

The NED 700ml will be available in select Dan Murphy's stores from mid-July while the RTD products will be available in selected stores nationally across Dan Murphy's and BWS aligned with consumer dark spirits consumption from late August.

The Endeavour ranging now provides NED with distribution in both major retailers, as well as extensive coverage across independent bottleshop networks. It is complementary to NED's current national retail distribution, which is also set to grow over the coming 12 months as outlined in an ASX announcement on 26 May 2023.

Top Shelf CEO, Trent Fraser, said:

"This ranging is a significant strategic milestone in our ambition to build NED by securing ranging in all major retailer banners. It is the culmination of many months of work and a critical first step in our relationship with Endeavour.
