## **Industry News**

On Thursday 06 July 2023, USA time, the Food and Drug Administration (FDA) confirmed its granting to Eisai Co. Ltd of full approval for Alzheimer's treatment, Leqembi (Lecanemab). This follows an accelerated approval of Leqembi by the FDA in January this year.

In its news release about the approval, the FDA noted the significance of its decision:

"Leqembi is the first amyloid beta-directed antibody to be converted from an accelerated approval to a traditional approval for the treatment of Alzheimer's disease. The drug works by reducing amyloid plaques that form in the brain, a defining pathophysiological feature of the disease."

The approval by the FDA was described by Teresa Buracchio, acting director of the Office of Neuroscience in the FDA's Center for Drug Evaluation and Research as "...the first verification that a drug targeting the underlying disease process of Alzheimer's disease has shown clinical benefit in this devastating disease".

As previously announced by Cogstate to the market on 28 September 2022, the confirmatory phase 3 Clarity AD study of Lecanemab, which supported the FDA's decision to approve Leqembi, had met primary endpoints showing a statistically significant reduction of a clinical decline in a global clinical study of 1,795 participants with early Alzheimer's disease. The study was conducted in collaboration between Eisai Co. Ltd and Biogen, Inc.

Cogstate was not party to the collaborative arrangement between Eisai and Biogen in respect of the confirmatory clinical study, nor does it have access to or awareness of information relating to the treatment other than as publicly released. However, Cogstate maintains its previously expressed view that the upside revenue for the Company's Healthcare business is expected to be dependent upon the release, reimbursement, and availability of proven Alzheimer's treatments.

This announcement has been approved for release by the CEO and Company Secretary.
