MELBOURNE, AUSTRALIA (28 July 2023): Hexima Limited (ASX:HXL) (**Hexima** or **Company**) a clinical stage biotechnology company, today releases its Appendix 4C and sets out below its quarterly activities report for the quarter ended 30 June 2023.

During the quarter, Hexima continued to focus on actively exploring opportunities for transactions with third parties which could enable the potential value of the Company's assets, including its intellectual property and other intangible assets, to be realised. The Board continues to advance this goal of maximizing shareholder value through a transaction, supported by the Company's contract Company Secretary and contract CFO.

As at 30 June 2023, Hexima had cash on hand of \$2.189 million, plus an expected R&D tax incentive receivable relating to FY 2023 of approximately \$600k.
