

Quarterly Update

Key Highlights

- Cash receipts of \$32.3M for the quarter up 15% from previous quarter and up 28% on the previous corresponding period.
- A net cash outflow of \$4.6M driven by the release of prepayments to suppliers and the final settlement payment for the asset purchase at Tank Industries.
- Operating net cash inflow of \$1.4M for the financial year.
- Cash balance of \$9.3M with zero drawn debt at the end of the financial year.
- EVZ continues to secure new contract wins across all businesses and maintains a solid contracted backlog position of circa \$80M.
- Market outlook remains positive across the Australian and Asian geographies providing further growth opportunities across our end market sectors of Energy and Resources, and Building Products.

GENERAL BUSINESS

EVZ has delivered a strong financial and operating performance, with cash receipts up 28% on the previous corresponding period.

During the quarter the group secured a number of new contract appointments to maintain our momentum and continues to build a diversified project portfolio across all our industry sectors and geographies.

The group continues to seek out new organic growth business opportunities and new business acquisitions to expand our market share in our two end markets, the Energy & Resources sector and the Building Products sector.

BROCKMAN ENGINEERING

The Brockman business is currently delivering the largest project in the group, the Viva Energy Strategic Storage project, which is located adjacent to the Viva Refinery in Corio, Geelong. The project recently achieved a milestone to complete the three tank shells allowing the next stage of the aluminium geodesic dome roofs to commence. The project is currently being managed in accordance with the budget and schedule, the contract value currently exceeds \$50M.

Brockman is also currently delivering a number of large steel water reservoirs for water authorities in NSW and Victoria in addition to several liquid fuel tanks. The business continues to build a diversified project portfolio and selectively expand the maintenance and operations support offering to improve the consistency of revenue and earnings contribution.

Tendering activity during the quarter remained high as industries aligned with our market segments continued to invest in new energy and water infrastructure.

SYFON SYSTEMS

Syfon Systems is benefitting from the buoyant market conditions in the Building Products sector delivering another strong performance in 4QFY23. Outlook in the Building Products sector remains strongly positive for FY24 which is supported by the historically high contracted backlog and current high tendering activity levels.

Syfon Asia is progressively returning to full operating capacity tracking the increasing demand for our services for new large social infrastructure and building developments in Malaysia, Indonesia and Vietnam. Our strategic partnership with Rucika in the Indonesian market is forecast to benefit from the increasing need for new built infrastructure over the next decade to form a significant part of our Asian business.

TANK INDUSTRIES

The Tank Industries business has been earnings accretive since acquisition, the business is currently aligning back office operations and business strategy with Syfon to maximise our market penetration and improve the operational performance. The suite of tank products are currently undergoing a value engineering phase to improve their market appeal for a wider client base.

Landfill Gas to Power Generation Facility, Western Sydney - TSF Power

TSF POWER

The TSF Power technical service operational support and power generation parts sales continue to grow and expand as we attract a wider customer base. Our services are in continuous demand as the use of renewable gas as an energy source rises in line with market demands for a lower carbon future in the transition to net zero.

Customer demand for our technical support and our value added offering has risen across all four of our operating segments: gas engine service and maintenance, gas engine spare parts sales, gas engine replacement and renewal, and standby power plant maintenance.

TSF Power is consistently pursuing new long term parts sale agreements and long-term operations support contracts with additional large institutional and waste management entities in Australia and New Zealand.

BALANCE SHEET AND CASH FLOW

EVZ reported an operating net cash inflow for the fiscal year of \$1.4M. The June quarter recorded a net cash outflow of \$4.6M driven by release of project prepayments to our suppliers and the final asset settlement payment for Tank Industries. The Company has \$9.3M in cash with zero drawn debt.

During the quarter, payments to related parties and their associates totalled \$52k. These related party payments consisted of consulting fees paid for non-executive Director related services. All payments were on normal commercial terms.
