Notice Pursuant to Section 708A(5)(e) of the Corporations Act

Dotz Nano Limited (**Company** or **Dotz**) (**ASX: DTZ**) gives notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) as follows:

- (a) The Company has issued 14,220,000 fully paid ordinary shares in the capital of the Company (**Shares**) at an issue price of \$0.20 per Share and 7,110,000 unquoted options exercisable at A\$0.35 and expiring on 28 July 2025 in connection with the Company's Private Placement, (refer to Dotz's <u>ASX Announcement 26 July 2023</u>).
- (b) The Shares rank pari passu with existing Dotz fully paid ordinary shares on issue and are part of a class of securities quoted on the Australian Securities Exchange.
- (c) The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- (d) As at the date of this notice, the Company has complied with:
 - the provisions of Chapter 2M of the Corporations Act, as they apply to the Company; and
 - Section 674 of the Corporation Act.
- (e) As at the date of this notice, there is no 'excluded information' (within the meaning of sections 708A(7) and 708A(8) of the Corporations Act) required to be disclosed under section 708A(6)(e) of the Corporations Act. As announced to the ASX on 19 May 2023 The Company has entered into a binding asset purchase agreement with H2 Blue Tech Limited to acquire its Carbon Dioxide (C02) capture assets and technology (the **Acquisition**).
