Valencia, Calif., USA, and Melbourne, Australia, 29 August 2023: Between 20 August 2023 to 23 August 2023 (United States) / 21 August 2023 to 24 August 2023 (Australia) AVITA Medical, Inc. (**Company**) issued a total of 72,393 fully paid shares of common stock in the Company (**New Securities**). 125 shares were issued as a result of the exercise of 125 unquoted Options. 72,268 shares were issued as a result of the vesting of 72,268 unquoted unrestricted stock units in the Company.

The New Securities will be quoted on NASDAQ, but may be converted into CHESSE Depositary Interests (**CDIs**) in the Company quoted on ASX at any time by the relevant holder. The Company seeks to rely on an exemption under section 708A of the *Corporations Act 2001* (Cth) (**Corporations Act**) with respect to the sale of any CDIs which are issued on conversion of the New Securities (in the instance that such conversion occurs).

The Company gives this notice under section 708A(5)(e) of the Corporations Act as modified by ASIC Class Order 14/827.

The New Securities were issued without disclosure to investors under Part 6D.2 of the Corporations Act.

As at the date of this notice, the Company has complied with:

- the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
- section 674 of the Corporations Act.

As at the date of this notice, there is no information that is 'excluded information' within the meaning of section 708A(7) and section 708A(8) of the Corporations Act.
