CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Dubber Corporation Limited [ASX:DUB] (**Company or Dubber**) has allotted and issued 19,314,184 fully paid ordinary shares on 12 September 2023, as detailed in the Appendix 2A released to the ASX today. The pending allotment and issue of these shares was announced to the ASX on 25 July 2023. Further to the Amended Appendix 3B released on 11 September 2023, the balance of the Tranche 2 Placement shares, being 7,528,571 shares, are expected to be allotted on or around 29 September 2023.

The Company gives this notice in accordance with section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) and states the following:

1. the shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
2. as at the date of this notice, the Company has complied with:
 - a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - b) section 674 and 674A of the Corporations Act;
3. as at the date of this notice, there is no excluded information for the purposes of sections 708A(7) and 708A(8) of the Corporations Act.
