Freehill Mining Limited (**Freehill** or **Company**) (ASX:FHS) is pleased to announce that on Friday, 15 September 2023, it issued the shares as set out in the table below.

Non-Executive Chairman Ben Jarvis, said:

"We are very encouraged by the support from investors for their participation in the Entitlement Offer and thank them for their participation. This additional funding gives us the necessary capital to advance operations in Chile where we are making good progress and we expect to shortly provide an update on some key developments related to the Yerbas Buenas operation. We will also seek to place the shortfall under the Entitlement Offer over the coming weeks and are encouraged by the level of inquiry thus far."

The Company is currently working on a number of key operational developments in Chile which it plans to communicate to shareholders on Tuesday, 26 September 2023. Progress has been impacted by the timing of Chile's Independence Day on 18 September 2023 which has led to some short term delays in completing and announcing these developments.

As such, the Company expects to have its securities reinstated to quotation upon lodging its 2023 audited financial statements and that operational update with ASX, which are expected to occur by 29 September 2023.
