XTEK's HighCom Completes A\$2.6m Ballistic Armour Order Delivery

Wednesday 27 September 2023. **XTEK Limited** (ASX: XTE, 'XTEK', 'Group') is pleased to announce that the Group's HighCom Armor Solutions Inc. (HighCom) business has completed fulfillment of the A\$2.6m order previously announced to the ASX on 17 July 2023, to supply its high-end ballistic body armour products to an undisclosed European customer.

The order, which comprised many thousands of HighCom's NIJ Level IV hard armour ballistic plates, was able to be quickly manufactured and promptly dispatched to the end user, almost a month earlier than was expected.
