

# Appointment of new Chair Lil Bianchi and retirement of Bruce Rathie

**Melbourne, Australia, 03 October 2023**: Respiratory imaging technology company 4DMedical Limited (ASX:4DX, "4DMedical", or the "Company") today advises that Chair and non-executive director, Mr Bruce Rathie, is retiring and will not be standing for re-election to 4DMedical's Board of Directors (Board). The Board thanks Mr Rathie for his significant contribution to the Company over the past four years in these roles.

The Company announces that Lil Bianchi, current non-executive director and Chair of the Company's Audit and Risk Committee, will take the role of Chair following Mr Rathie's retirement. Ms Bianchi has been a director of 4DMedical since December 2019 and has international board and CEO experience across many sectors including health, finance and infrastructure. Her professional background is in technology and AI.

As a result, the Company advises the withdrawal of Item 4 from the Notice of Annual General Meeting (AGM), which was lodged with the ASX on 28 September 2023. Item 4 relates to the re-election of Mr Bruce Rathie as a director of the Company.

The withdrawal of Item 4 will not affect the validity of the proxy form provided in connection with the AGM or any proxy already submitted in respect of the remaining items. The AGM is scheduled to be held on Thursday, 2 November 2023 at 10.00am (AEDT) at The Woodward Conference Centre, Level 10, Melbourne Law School, The University of Melbourne, 186 Pelham Street, Carlton, Victoria 3053.

### Mr Bruce Rathie commented:

Over the past four years, I have been pleased to lead the Company through listing on the ASX and establishment in the Australian and US markets. My goal as Chair through these formative years at 4DMedical was to establish and embed governance structures required as a publicly listed company. With these structures now in place, this AGM provides an opportune moment for me to pass the baton to Lil Bianchi and for me to pursue other opportunities.

## Incoming Chair, Ms Lil Bianchi, commented:

I am absolutely delighted to take on the role of Chair at this exciting moment in the Company's journey. 4DMedical is well positioned with globally unique technology, a strong board and strong management team, and is well capitalised to execute on its commercialisation strategy.
