### IMEXHS signs new A\$2.0m radiology services contract with Colombia's National Police Force

#### Highlights

- IMEXHS Radiology services (RIMAB) has won a new A\$2.0m contract with Colombia's National Police Force, IMEXHS's largest contract to date with this institution.
- Fifteen-month agreement is expected to contribute A\$1.6m in Annual Recurring Revenue (ARR).
- IMEXHS Enterprise Software is in the process of being installed at the hospital and the service will commence immediately.

**IMEXHS Limited (ASX: IME) ("IMEXHS" or "the Company")** today announces that RIMAB, the Company's wholly owned subsidiary has secured a new A\$2.0m contract with Colombia's National Police Force.

The initial fifteen-month agreement is expected to contribute A\$1.6m in Annual Recurring Revenue (ARR).

This new contract will commence immediately and contains an automatic seven-and-a-half-month renewal provision. The contract requires minor investment in capital expenditure as a substantial part of the service will be provided using RIMAB's existing radiology services infrastructure.

The Company will provide radiology outsourcing services to circa 48,000 patients.

Under the agreement, IMEXHS's Enterprise Software will be implemented at a new Police Hospital in the Southern region of Bogota.

RIMAB's primary focus will be on delivering radiology services across its existing radiology services infrastructure. The contract also includes a small number of pathology and nuclear medicine studies.

IMEXHS Co-Founder and CEO Dr Germán Arango said, “We are proud to share that we have secured our largest contract to date with Colombia’s National Police Force. This significant partnership highlights the trust and confidence that one of Colombia’s most important institutions places in IMEXHS which underscores the quality of our radiology services and the advantages offered by our Enterprise Imaging technology.”
