

Quarterly Activities Report for the Quarter Ended 30 September 2023

Melbourne, Australia – 17th October 2023: SelfWealth Ltd (ASX:SWF) (“SelfWealth” or “the Company”) provides the following update on its activities for the quarter ended 30 September 2023.

Summary

- Positive operating cash flow of \$730k for the quarter ended 30 September 2023.
- September 2023 quarter is the fourth consecutive quarter of positive operating cash flow.
- Total operating cash flow of \$2.36 m for the 12 months from 1 October 2022 to 30 September 2023.
- Cash on hand: \$12.5m as at 30 September 2023.
- SelfWealth continues to have no debt.

Quarterly Activities and expenditure: During the quarter, the Company’s business activities continued to be the provision of online, low-cost share trading services on the Australian, USA and Hong Kong stock exchanges. There were no material changes to business activities for the quarter.

In the quarter, the business commenced a program to rationalise its cost base to create longer-term operational efficiencies. Operating expenditure incurred on business activities during the quarter totalled \$6.6m.

This compares favourably to operating expenditure of \$6.8 million in the previous quarter and \$8.0m in the previous corresponding period ending 30 September 2022.

Payments to related parties: In accordance with listing rule 4.7C.3, payments made to related parties and their associates which are included in item 6.1 of Appendix 4C comprise the Director’s fees, remuneration and superannuation at commercial rates for the quarter.

The Board of SelfWealth Limited has authorised the release of this announcement to the market.
