Quarterly Activity Report: July – September 2023

Highlights:

26 October 2023

- Q1 FY24 Sales of \$4.4M
- \$226K positive operating cash flow for the quarter
- \$1.6M cash on hand
- Seasonal product listings commenced, projected to deliver improved margin mix
- New tech products commencing Manufacturer-to-Consumer (M2C) sales in Q2 FY24, targeting the upcoming retail season
- No requirement to raise capital in the foreseeable future

Pure-Play online retailer Harris Technology Group Limited (ASX: HT8) ("Harris Technology" or the "Company") is pleased to provide its activity report for the September 2023 quarter (Q1 FY24).

Operations Update

For the September quarter, Harris Technology generated sales revenue of \$4.4M with a steadily increased mix of household product category.

A net operating cash inflow of \$226K was recorded in the quarter.

Retail trading conditions continued to be difficult with Harris Technology maintaining its prudent cash management strategy and limiting inventory investment through the quarter.

As of 30 September 2023, inventory on hand was \$4.1M, a decrease of \$0.6M on the June 2023 value of \$4.7M. This included \$3.4M of purchased inventory during the September quarter, indicating continued inventory holding quality to best position Harris Technology for the upcoming retail season.

Since expanding into the Household category in 2022, Harris Technology has seen a steady uplift in average product margins, particularly from seasonal ranges which include Christmas and summer holiday products. In preparation for these trends, Harris Technology commenced listing and distributing these products earlier than previous years with unsold inventory from previous seasons generating sales in September and October already. The Company continues to monitor these high-margin product sales and will replenish across various online marketplace channels accordingly.

The Manufacturer-to-Consumer (M2C) division continues to generate sales from a small range of private-label tech products in the United States, Canada, United Kingdom, Singapore and at home in Australia. Sales data generated in these territories, some of which are less impacted by retail headwinds, provide insight into consumer trends.

During the December quarter, investment in the M2C division will increase with several highmargin products flagged for online listings and distribution in new regions.

Under the M2C division strategy, Harris Technology does not operate warehousing facilities but instead leverages Marketplace distribution facilities for fulfilment at lower distribution costs.

Harris Technology CEO, Garrison Huang commented, "Increased activity from the M2C division has been encouraging and highlights an opportunity for Harris Technology to sell private label tech products into more international marketplaces. While demand for Harris Technology's traditional range of IT products has slowed over the past 12 months, we're seeing consumer behaviour starting to turn with greater demand for private-label and refurbished products as an alternative to premium tech brands."

"We are actively in discussions with international manufacturers and look forward to adding more private label products to our eCommerce channels in the coming months in preparation for the busy retail season that includes Black Friday, Cyber Monday, Christmas and Boxing Day."
