# Newmont Corporation (ASX: NEM) – Admission and Quotation – Foreign Exempt Listing, Deferred Settlement Trading

## **Description**

Newmont Corporation ('NEM'), a foreign company registered in Delaware, United States of America, was admitted to the Official List of ASX as an ASX Foreign Exempt Listing on Thursday, 26 October 2023. Following completion of all necessary conditions to a proposed scheme of arrangement ('Scheme'), NEM, through its wholly-owned subsidiary Newmont Overseas Holdings Pty Ltd, will acquire all of the issued share capital of Newcrest Mining Limited ('NCM').

Eligible NCM Scheme shareholders that are on the Australian NCM share register on the record date will have their NCM ordinary shares acquired in exchange for 0.400 CHESS Depositary Interests ('NEM CDIs') representing ownership interest in shares of NEM common stock.

As an ASX Foreign Exempt Listing, NEM is primarily regulated by the listing rules of its home exchange (being the New York Stock Exchange) and is exempt from complying with most of ASX's Listing Rules.

Official Quotation of NEM CDIs representing shares of NEM common stock at a ratio of 1 for 1 is expected to commence at 11:00am (AEDT) on Friday, 27 October 2023, initially on a **deferred settlement basis**.

NEM did not raise any capital in conjunction with its listing on ASX.
