First quarter update and cashflow

Highlights:

- Cash Receipts from sales in excess of \$253k for the quarter.
- \$859k in cash held at end of quarter.

30th October 2023 – IoT solutions company, Constellation Technologies Limited (ASX: CT1) (the "Company" or "Group") is pleased to provide a summary update on its activities for the quarter ended 30 September 2023.

Sales

During the quarter, the Company continued to receive payments from existing and new customers in excess of \$253k for the quarter.

Sales for the Company's Callisto platform continue to steadily increase each month. The cashflow effect of these sales will however not be seen until future quarters.

Several leading commercial catering and food distribution groups have continued to trial and use the newly enhanced Food Safety & Compliance and cold chain monitoring modules within the Callisto ecosystem. Confidence in the product has led to an increase in trial sites being on-boarded across Australia in various metro and remote 'out-back' locations.

Expenditure & other activities

The Company continues to operate on a cost efficiency basis, with a net cash burn from operating activities of \$237k for the quarter. Operating costs were higher than average this quarter due to the payment of annual operational and corporate compliance costs. Cash burn in future quarters is expected to be lower.

Related party cash payments for the quarter were \$63k and consist of salary related payments for CEO, Kartheek Munigoti; director's fees to two of the Company's two non-executive directors and office rental and legal fees paid to entities associated with Mr Nicholson. No cash payments have been made to Mr Malone for his directors fees to date.

The board thanks all shareholders for their continued support and interest in the Company.
