INFORMATION FOR SINGAPORE DEPOSITORS – RETAIL ENTITLEMENT OFFER

On 25 October 2023 AVJennings Limited (ASX:AVJ) (“AVJennings”, or the “Company”) advised that the closing date of the retail component of its \$30.4 million fully underwritten 1 for 2.67 pro-rata accelerated renounceable entitlement offer (“Equity Raising”) announced on 11 October 2023 (“Retail Entitlement Offer”) will be extended to Friday, 3 November 2023.

The Central Depository (Pte) Limited (CDP) holds shares in the Company on behalf of certain persons (Singapore depositors). For Singapore depositors, the retail offer will close two days earlier on Wednesday, 1 November 2023 to allow CDP sufficient time to process applications for rights from eligible Singapore depositors and submit its application on behalf of those depositors to the Company’s Share Registry in Australia.
