If any additional financing facilities have been entered into or are proposed to be entered into after quarter end, include a note providing details of those facilities as well. \$2,950,000 was raised through the issue of Secured Convertible Notes on 7th December 2018 to Thundering Herd Fund No.1 and Thundering Herd Pty Ltd with an annual coupon of 15% payable quarterly in arrears. On 18th May 2020 the maturity date was extended by 1 year to 7th December 2021. On 22nd July 2021 the maturity date was further extended to 1st July 2022. Subsequently, with an effective date of 22nd December 2021, the maturity date was further extended to 1st February 2023. On 4th November 2022 the maturity date was further extended to 1st February 2024. \$650,000 was raised through the issue of Unsecured Convertible Notes on 25th January 2018 to various note holders with an annual coupon of 10% payable quarterly in arrears. On 18th May 2020 the maturity date was extended by 1 year to 25th January 2022. The Unsecured Convertible Notes are subject to a subordination agreement and will therefore not be repaid prior to the Secured Convertible Notes. \$350,000 was raised on 31 August 2023 as short term unsecured loans from two DomaCom shareholders with an initial interest rate of 15% for 3 months repayable on the completion of the current proposed capital raise announced on 10 October 2023 that is expected to complete prior to 31 January 2024.

Answer: Yes. DomaCom expects to be able to continue its operations and to meet its business objectives. DomaCom continues to grow fee revenue and control costs. The capital raise announced on 10 October 2023 will create a stable financial position to allow the business to continue to grow.
