### Pre-register to ask questions via telephone during the AGM

### Proxyholders must obtain online registration details if they wish to vote online during the AGM

Proxyholders who wish to vote online during the AGM require a unique email invitation link, which can be obtained by calling NAB's Share Registry on +61 3 9415 4024 prior to the meeting day or during the online registration period, which opens 1 hour before commencement of the AGM.

- **in person:** Shareholders and Proxyholders are welcome to attend the AGM in person at the Fullerton Hotel Grand Ballroom, No. 1 Martin Place, Sydney

Registration (online and at the venue) will open 1 hour before the AGM commences.

### How to vote and participate online

Shareholders and Proxyholders can vote online through our online AGM platform at any time from the commencement of voting until the close of voting, as announced by the Chair.

**To vote,** follow the instructions and on-screen prompts. Note only Shareholders and validly appointed Proxyholders can vote and ask questions at the AGM.
