Shareholder approval was obtained at the AGM held on 17 November 2022 as such the buyback may be conducted outside the 10/12 limit and the Company may buyback up to 116,610,809 shares. The reason for the buy-back is ongoing capital management. The buyback may cease earlier if the maximum number of shares is bought back prior to the period end date. The Company reserves the right to suspend or terminate the buyback at any time.
