Melbourne, Australia, 29th November 2023: Respiratory imaging technology company 4DMedical Limited (ASX:4DX, "4DMedical", or the "Company") today announces that it has signed a Memorandum of Understanding (MoU) with Koninklijke Philips N.V. (NYSE: PHG or "Philips"), a leading global healthcare company, to establish a strategic collaboration to expand federal and commercial sales opportunities for XV Technology[®] in North America.

Commercial partnership greatly expands 4DMedical's reach and access

Signing of this MoU represents a major step forward in the Company's commercialisation strategy, particularly within the VA. Philips has a long-established and significant existing partnership with both the VA and the Department of Defense (DoD), which includes a 45-year relationship, deploying 35% of the critical care information systems across the VA, and having Philips imaging solutions in 50% of VA hospitals and Veterans Integrated Service Networks (VISNs). Accessing this team of industry experts, with unparalleled relationships in global healthcare, provides an unprecedented opportunity to accelerate 4DMedical's go-to-market activities, particularly in the VA.

Philips' strategic cooperation with 4DMedical focuses on scaling Veteran access to XV Technology[®]

Philips is a global leader in health care with €18.5 billion (\$30.8 billion) in revenues reported last year, and employs approximately 75,000 staff globally. Establishing a strategic cooperation

Under the terms of the MoU, 4DMedical and Philips will negotiate a Collaboration Agreement for North America. The initial focus of the partnership will be to offer 4D lung imaging as a critical screening solution for Veterans exposed to burn pits. It is intended that 4DMedical's XV Technology® will be added to Philips' product catalogue and offered as a third-party solution. Subsequently, the parties intend to expand access to both software and hardware solutions, including to other US based Federal agencies and commercial organisations in North America. The parties will also consider other markets outside of North America for expansion.

The initial step in this collaboration will be signing a "Teaming Agreement" to jointly advance a pilot to evaluate Veterans for deployment-related respiratory disease.

Agreement signed at RSNA convention

Senior members of the leadership teams of Philips and 4DMedical met in Chicago at the Radiological Society of North America (RSNA) convention ahead of the MoU signing. Also in Chicago for this meeting was 9th Secretary of the VA, the Honourable Dr David Shulkin. Dr Shulkin commented: "Partnering with a leading healthcare company like Philips provides 4DMedical with a unique opportunity to accelerate their mission to help Veterans with deployment-related respiratory disease. With 4DMedical's commitment to better lung health outcomes, and Philips' size and scale, the opportunities for this partnership to deliver for active military, first responders and Veterans is clear."

4DMedical MD/CEO and Founder Andreas Fouras said:

To partner with a healthcare powerhouse such as Philips is a phenomenal opportunity for 4D to accelerate our mission. The depth of commitment to Veterans by the team at Philips North America has been palpable throughout our 6-month long discussions. I continue to be impressed by their leadership in this space, and I am convinced that a partnership with Philips will dramatically accelerate the scaling of our offering within the VA. I am incredibly excited by the reach this will give our technology, and importantly, the impact this will have for millions of Veterans and their caregivers.
