

Qualitas Real Estate Income Fund (ASX: QRI) Voluntary Escrow Extension

29 November 2023: The Trust Company RE Services Limited as the responsible entity (RE) of the Qualitas Real Estate Income Fund ARSN 627 917 971 ("QRI") advises that the 5 year escrow period in respect of 6,250,000 ordinary QRI units ("Escrowed Units") held by Qualitas Property Partners Pty Ltd ("QPP"), a wholly owned subsidiary of Qualitas Limited (ASX: QAL), expired on 26 November 2023. The voluntary escrow arrangements for these units are summarised in section 13.6 of QRI's PDS for its IPO dated 8 October 2018.

QPP has agreed with the RE to extend the voluntary escrow arrangements by an additional 12 months subject to execution of a deed amending the Voluntary Restriction Deed. Following execution of the amending deed, the Escrowed Units will be released from voluntary escrow with effect on 27 November 2024.
