Optus Wireless

The Company's Telecommunications Division has secured a three-year contract extension to its national wireless agreement with Optus. Under the agreement, Service Stream will continue to support Optus with the provision of site acquisition, design, construction, and upgrade services across their national wireless infrastructure networks.

Multinet Gas Networks
